- a) The seats shall be reserved in respect of SC/ST (one seat) and women (two seats) as per sub-section (3) of section 41 of the MSCS Act, 2002.
- b) At the time of calling nominations, information regarding contestants belonging to women or SC/ST along with appropriate documents/certificates shall be captured including whether the candidate will contest the election from the reserved seat.
- e) Nomination can be filed either under reserved seats (for SC/ST and Women) or nonreserved/general seats.
- d) Separate ballot paper be used for reserved seats.
- e) If the stipulated minimum representation of the above categories in the Board is not achieved, such reserved seat(s) shall be kept vacant.
- 2. The ROs shall ensure that the above guidelines are complied with and brought to the notice of members of the multi-state cooperative society concerned.
